driving on the wrong side of the road as well as disregarding traffic signals at the intersection of Northside Dr. and Marietta St.

While parked I observed one person, a black male, pushing his blue Yamaha Banshee ATV off the roadway towards the other side of 881 Marietta St. I ran after this male and upon my pursuit I slipped on some gravel that was on the sidewalk which caused me to fall and hit my leg on the concrete, causing two abrasions on my right leg and tearing my pants. I quickly got up and began to run after the suspect again. When I was behind the suspect he turned around and noticed me and started to run northbound on Northside Dr. Shortly after a fellow biker picked him up and drove him away from the scene. I was able to secure the ATV. I went back to my car and noticed that the windshield had been smashed in. The suspect drove by several times on the back of his friend's ATV checking on the status of his ATV. The suspect is a black male with short black hair, about 6 feet 230 lbs, wearing a white tank top and blue jean shorts. His ATV is a blue Yamaha Banshee. The id number on the motor is 3gg132270 and the id number on the frame is a black red liquid that is suspected codine. The liquid was turned in at property for analysis and the bottle was turned in as evidence.

Sgt. Collins #3595 came out to the scene. ID Unit Ware #7325 came out to the scene to take pictures of the car and my injuries. CID Inv. Sutton also responded to the location. The incident was captured on the watchguard camera on patrol car #31223. Grady bus 364 came on scene to bandage my abrasions. There is possible footage of the rear of the patrol car from Delia's Chicken Sausage Stand. A-Tow came on the scene to remove the patrol car from the scene as well as the ATV.
