The male was in an area known for sexual acts after dark. Therefore, I stood back to watch the male's activities.

The area in which the male stood was slightly inclined compared to my location (southwestern quadrant of the park). His position was also closer to the street which allowed me to see very clearly using the lights from the street and sidewalk. I witnessed the male feeling on his penis from the outside of his pants. He then started to walk towards me at some point. The male completely exposed his penis and was masturbating (stroking) with his right hand while walking in my direction. In turn, I stood next to a tree to prevent the male from noticing the reflective tape on my City of Atlanta Police bicycle uniform. I allowed the male to get approximately 7-10 feet away from me before I used my issued flashlight to shine light on the male. The male immediately fled on foot. I ran behind the male while yelling, "Police, STOP!" The male looked back at me multiple times but continued to run towards the sidewalk and street. He then ran across 10th Street and its traffic. I chose not to run into traffic but kept up with the male by running through the park. The male continued to run along the sidewalk until he reached Argonne ST NE. He then made a left turn onto Argonne ST and continued to run. I continued to watch the male run while I waited to cross 10th Street and its traffic near Argonne ST NE. The male had stopped to tie his shoes. I got approximately 10-15 feet from the male before he noticed my approach. The male immediately stopped fixing his shoes and started running again. The male approached 9th Street, turned left and continued to run along the sidewalk. I ran along the opposite sidewalk and then into the street. The male noticed I was closing the gap on the distance between the two of us and surrendered near 341 9th Street. Specifically, the male stopped running and started following my verbal commands. I advised the male to get on the ground and to put his hands behind his back while on the ground. The male did so. I then placed the male into custody and helped him to stand to his feet. We had ran approximately 0.25 miles from the original location in the park. I advised the male that we would walk back in the same direction in which he had ran to reach my patrol vehicle. The male then asked me if he could get his identification from his vehicle. I advised the male that I would not allow him to go to his car to retrieve his identification for safety purposes. I continued to escort the male in custody down Argonne ST NE and across 10th Street into Piedmont Park. We then crossed the meadow in which the male was originally seen in. The male told me to call my supervisor, Major Peek. I advised the male that Major Peek was not my supervisor. I then asked him if he would like to speak to a supervisor. The male stated "Yes". I then advised the dispatcher of the male's request. I searched the male's person once we reached my patrol vehicle. The male had two condoms in his right pocket. I relocated to the CNN Precinct to afford the male the opportunity to speak to the supervisor.

The male provided the name of JEFFREY MANN and date 1962. A wanted person's check of Mr. Mann did not report him with any active warrants. Mr. Mann was transported to the City Jail for booking on Indecency and Obstruction of Officer charges. There were no injuries during his arrest. Mr. Mann requested his vehicle's keys be released to a co-worker. Arrangements were made for the keys of the vehicle to be released to the co worker.
