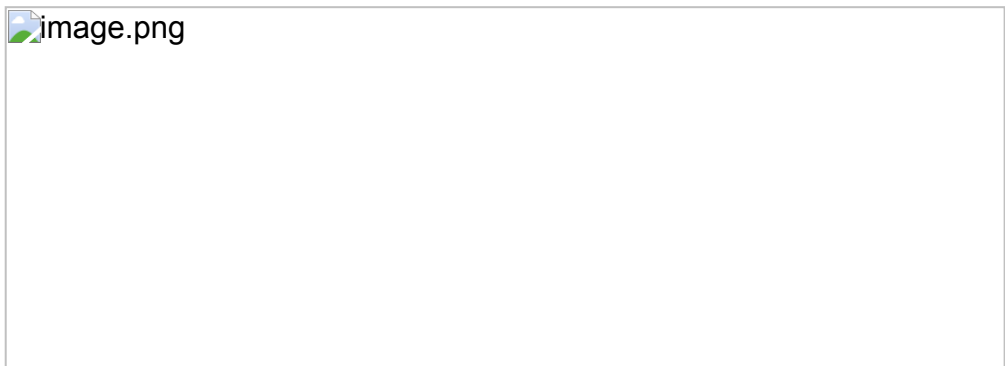

You are receiving this email because your Georgia certificate will expire June 30, 2020. Although we are under COVID-19 shelter in place in restrictions, GaPSC recommends that we continue to process renewal applications. Under their guidance, we will complete criminal backgrounds when COVID-19 restrictions are lifted and resume business as normal. Attached is the necessary paperwork to complete your renewal. The paperwork should be ***completed and scanned*** to email at awalker@csdecatur.net by **May 15th**. This will ensure time for us to upload your paperwork to GaPSC while working remotely. The Verification of Lawful Presence form requires a notary; we are

altering the "in-person" notary requirements during this process, so please attach a copy of an unexpired form of ID for me to verify identity or you can get your form notarized at your local financial institution as well.
